Commission Acting Chair Morefield opened the Tobacco Commission meeting at 12:04 p.m.

Commissioner Kilgore moved to approve the remote participation of Commissioners Aird, Foster, Jennings, Lucas, Marshall, and Wilson; Commissioner Merrick seconded the motion; all members voted to approve the motion.

Director Campos called roll and confirmed that a quorum was present.

Commissioner Pace moved to approve the minutes from the previous full Commission meeting on September 26, 2024; Commissioner Arnold seconded the motion; all members voted to approve the motion.

The meeting was opened to public comment, and there was none.

Pace moved to postpone the election of Chair and Vice-Chair until the end of the meeting; Commissioner Lucas seconded; all members voted to approve the motion.

Campos presented the Executive Director Report on TRRC's thirteen strategic initiatives and invited Judson Hill, formerly of Georgia State Senate, to speak about the value of developing a fishing lodge in the footprint.

Arnold presented the report for the Energy Ingenuity Committee.

Commissioner Aird moved that the Commission accept as a block the Energy Committee's recommendations for Energy Catalyst-Planning Grant project numbers 4317, 4311, 4322, 4323, and 4320; and for Energy Execution Grant project numbers 4312 and 4315; Arnold seconded; all members voted to approve the motion.

Aird moved that the Commission approve the Energy Committee's recommendation to table Energy Catalyst-Planning Grant project number 4318; Arnold seconded; all members voted to approve the motion.

Commissioner Cox presented the Education Committee report and moved that the Commission accept as a block the Committee's recommendations for the Advanced Manufacturing Workforce Training project number 4301; Workforce Training Program project numbers 4305, 4302, 4304,4307,4306,and 4308; Commissioner Frederick seconded; all members voted to approve the motion.

Commissioner Cox moved that the Commission accept the Education Committee's recommendation to approve the Talent Attraction Program (TAP) exception request from M. Dianis; Commissioner Lohr seconded; all members voted to approve the motion.

Commissioner Shelton presented the report for the Southern Virginia Committee and moved that the Commission accept the Committee's recommendations to approve a

final, one-year extension to January 31, 2026, for project number 3590; Commissioner Kilgore seconded; all members voted to approve the motion.

Pace presented the report for the Incentives & Loans Committee and moved that the Commission accept the Committee's recommendations to authorize staff to alter the current guidelines of the Commission's new Economic Development Workforce Housing Incentive Pilot Program by increasing the maximum per-unit incentive to \$50,000 and changing the income level target for these new units to generally be between 80 and 150% of Area Median Income; Commissioner Wilkins seconded; all members voted to approve the motion.

Pace moved that the Commission accept the Incentives & Loans Committee's recommendations to approve a Tobacco Region Opportunity Fund (TROF) award of up to \$50,000 for Project Maggie with the exceptions for wages, performance period, and award amount as discussed in closed session of the Incentives & Loan Committee; Kilgore seconded; all members voted to approve the motion.

Kilgore presented the Southwest Virginia Committee report and moved that the Commission accept as a block the Committee's recommendations to make the following awards for: Agribusiness project numbers 4293 and 4294; Business Development project number 4239; Other Economic Development project numbers 4292 and 4288; Sites and Infrastructure project numbers 4295 and 4297; and Tourism project numbers 4290, 4299, and 4289; and to table Business Development project number 4296; ; Arnold seconded; all members voted to approve the motion.

Commissioner Blevins presented the report of the Strategic Planning Committee. The Committee received updates from Virginia Tech on the Strategic Plan process; no actions were taken by the Committee.

Morefield informed the Commission that there would be no discussion on the Special Tourism Opportunity Request.

Campos introduced the review of the Commission's meeting schedule and the possibility of adding a fourth round of meetings in a year. Deputy Director Versen addressed the Executive Committee's November 25, 2024, discussion on the addition of a fourth meeting, which covered several possible approaches, including: increasing the number of grant rounds per year; changing the grant cycles to accept rolling applications; and, if adopted, scheduling that fourth meeting virtually and during the summer.

Versen introduced an updated electronic meeting policy that reflects the updated requirements at the state level.

Pace moved to adopt the updated electronic meeting policy; Lohr seconded; all members voted to approve the motion.

Versen reminded the Commission's citizen members that they must submit a financial disclosure form by the February 1 deadline; they should have received an email from the Ethics Council with information on filing this form online.

Morefield moved on to the election of the Chairman and Vice-Chair of the Commission, noting that members of the administration would abstain from this vote and calling for nominations.

Pace nominated Commissioner Will Morefield for the position of Chairman of the Tobacco Commission; Marshall seconded; all members voted to approve the motion.

Pace nominated Commissioner Lashrecse Aird for the position of Vice-Chair of the Tobacco Commission; Marshall seconded; all members voted to approve the motion.

Campos confirmed there was no new business.

Pace noted that the General Assembly Session was scheduled to start the next day and relayed that legislation was being put forth to expand the Commission's footprint, which he opposes.

Chair Morefield adjourned the meeting at 1:09 p.m.
