LEADERSHIP MESSAGE:

From Chairman Ruff and Vice-Chair Morefield

The past year has been one of success, but also change, for the Commission.

The Commission has a long history of being an early partner in investments that have made a huge difference to those living in Southern and Southwest Virginia. From Broadband expansion efforts that make it possible for businesses to thrive and allow our kids to get their schoolwork done, to site development efforts that have attracted major employers, education and workforce development programs that ensure we have a well-trained and highly capable workforce, and more. The Commission continued its work in many of these areas, welcomed new individuals with new experience and ideas to its staff, and evolved to better suit the needs of the communities it serves.

Over the past year the Commission invested in a wide range of projects including support for our community colleges and workforce development centers, helped bring PBS programming back to Southwest Virginia, supported cattle farmers across Southern Virginia and much more.

In Southwest Virginia, The Birthplace of Country Music Museum in Bristol draws visitors from far and wide to learn about and experience the rich history of country music. When the museum sought to expand, the Commission was excited to partner with them on a project that will add a recording and radio production area, educational space and more to a facility that is already a source of great pride for Southwest Virginia and the Commonwealth as a whole.

InvestSWVA, a public-private business attraction and marketing campaign for Southwest Virginia created by the Tobacco Commission and backed by both the Commission and partners from private industry, has been incredibly successful. Folks from rural Virginia know that if you can get a company to come see all that rural Virginia has to offer from the great people to the vibrant communities, natural beauty and more they are very likely to want to locate there. InvestSWVA is proving that to be true with commitments from a growing number of top employers to locate in the region and more on the way.

In Southern Virginia, the Commission supported the National D-Day Memorial in Bedford as they add the first indoor museum space to a national monument that seeks to preserve the lessons and legacy of D-Day. The D-Day memorial attracts nearly 60,000 visitors a year, many of whom are from outside Virginia, and are introduced to all that our Commonwealth has to offer.

In South Boston, the Commission is proud to have been able to once again partner with the SOVA Innovation Hub as they add 13,000 square feet of space to their campus that will be used to encourage entrepreneurship, innovation, collaboration and build on the region's reputation as an emerging rural technology hub.

These are just a few examples of the many impactful projects the Commission supported this past year, and we encourage you to take a look at the full list of supported projects contained in this report.

The Commission is always looking for ways to be more impactful for the Communities it serves and Governor Youngkin's Compete to Win plan outlines a number of areas in which the Commission can help produce results for the Tobacco Region. Workforce development, site and infrastructure development and driving innovation are all areas that the Commission has traditionally played a leadership role in. Increased concentration on, and investment in, key sectors like energy and agriculture will also help the Commission continue to be a catalyst for growth well into the future.

The Commission also welcomed two new members to our staff leadership. Acting Executive Director James E. Campos was appointed by Governor Youngkin in January to lead the Commission's staff. He brings a wealth of experience in economic development, energy, and workforce issues, all of which are major areas of focus for the Commission. James is particularly interested in the opportunities the energy sector can bring to Southern and Southwest Virginia, in terms of jobs and investment, and leveraging that to help the Commission contribute to the goals of Governor Youngkin's ambitious Compete to Win plan for the Commonwealth.

Stephen Versen joined the Commission as Deputy Director and has extensive experience in rural economic development in the Commonwealth, particularly in the agricultural sector. Agriculture has long been a top priority for the Commission and will be an area of increased focus moving forward.

Both energy and agriculture present huge opportunities for our communities so having leaders in those fields, like James and Stephen, working for the Commission will be vital.

As the Commission enters its 25th year of serving the communities of Southern and Southwest Virginia, we could not be more excited about the opportunities that lie ahead. ABOUT

The Tobacco Region Revitalization Commission was formed by the General Assembly in 1999 to revitalize Virginia's tobacco region and compensate tobacco farmers for the decline in tobacco production. Funding for these activities comes from the State's share of the 1998 Master Settlement Agreement (MSA) between 46 state attorneys general and large tobacco manufacturers. The Commission was awarded half of the annual payments from Virginia's share of the MSA and successfully sought bond funding to replace that revenue stream with a single, static fund. Chapters 31 and 31.1 of Title 3.2 of the Code of Virginia contain statutes governing various aspects of the Commission.

The Commission's compensation program to tobacco farmers (indemnification) made payments to Virginia flue-cured and burley tobacco producers and quota holders to compensate them for their losses associated with the decline in federal tobacco quota levels (an aggregate loss of \$479 million). Many producers used the payments to help pay off debt and keep their farm operations running while they transitioned to crops other than tobacco. By 2013, the Commission along with other partners, had indemnified 100% of the aggregate loss satisfying its statutory obligation to indemnify burley and flue-cured tobacco producers and quota owners. From 1999 to 2013, the Commission made available \$309 million together with \$170 million from other sources for indemnifying losses.

With the completion of indemnification, the Commission's sole purpose is the revitalization of tobacco-dependent communities by awarding grants and loans for programs that support that goal.



The Southern Virginia Higher Education Center IT Academy offers hands-on training in networking, cybersecurity, Linux, cloud administration and more to prepare adults with the skills and certifications required for employment in Southern Virginia's growing IT sector.

ORGANIZATION

The Commission has six standing committees. Four committees evaluate grant and loan proposals from eligible applicants and make recommendations to the Commission as to what projects should be funded, in what amounts, and whether funding should be in the form of a loan or a grant.

The committees that consider funding proposals are Southern Virginia, Southwest Virginia, Education, and Incentives and Loans. The work of the former Agribusiness, Research & Development, Special Projects, Southern and Southwest Economic Development committees continues in the Southern Virginia and Southwest Virginia committees. The Education Committee aims to prepare citizens for new-economy employment through GED and workforce development, higher education scholarship programs for the two regions and competitive grants to community colleges as well as other post-secondary educational entities. The Incentives and Loans Committee oversees the Commission Tobacco Region Opportunity Fund (TROF) program as well as the Commission's Community and Business Lending (CBL) program. TROF provides performance-based monetary grants and loans to tobacco region localities to assist in the creation of new jobs and investments, whether through new business attraction or existing business expansion. The CBL program provides access to capital in the tobacco region while contributing to the Commission's financial sustainability by providing low-interest loans to qualifying applicants and projects.

The Commission's non-grantmaking committees are the Executive Committee and Strategic Planning Committee.

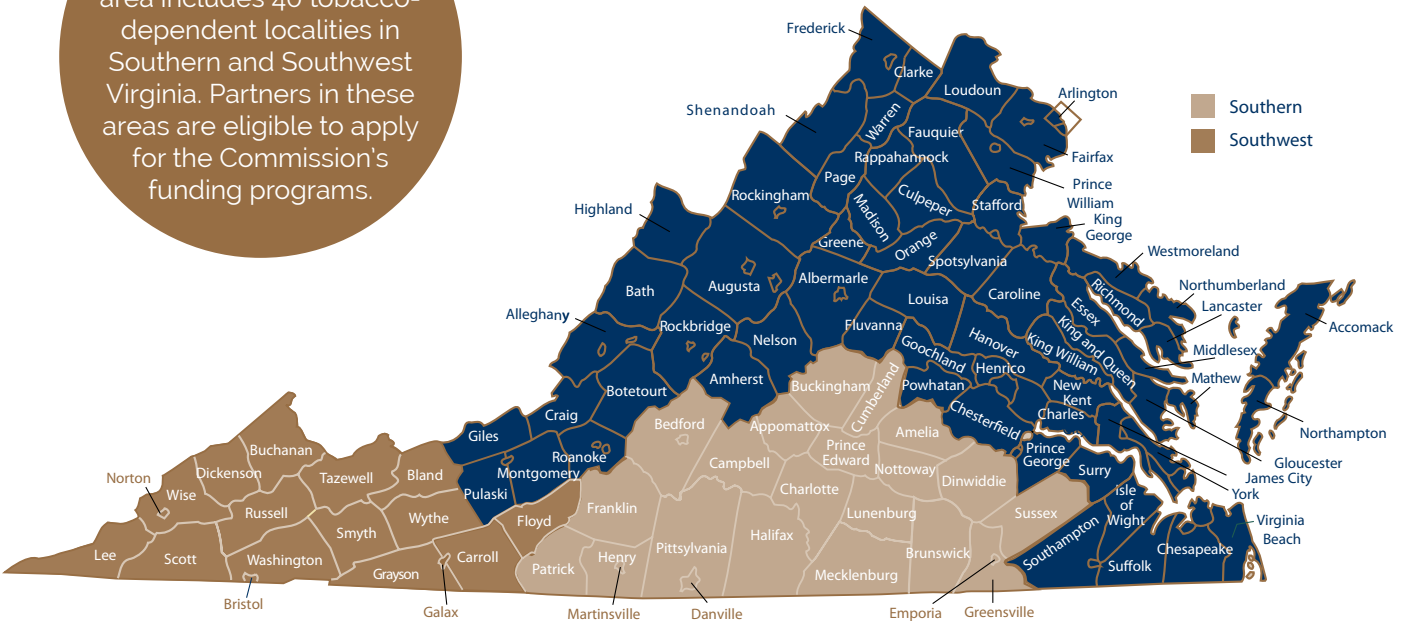

IpierionX chose South Boston and Halifax County as the site for their first titanium demonstration facility. The facility will create over 100 new jobs and over \$80 million in investment.



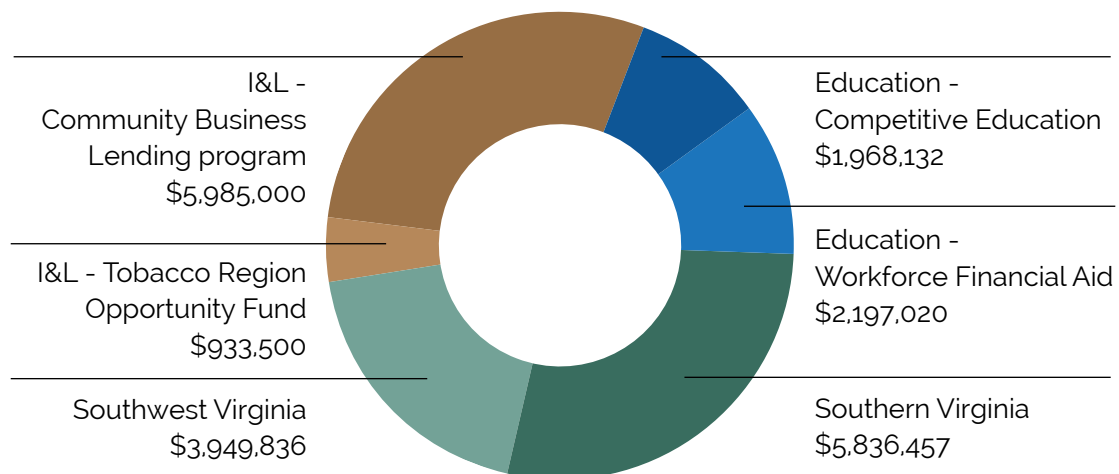
